RoHS DISCLOSURE



SECTION I: BACKGROUND & IDENTIFYING RoHS SUBSTANCES

A new RoHS directive (2011/65/EU) was introduced in 2011. This new amendment, RoHS 2, extended RoHS' initial scope of the requirements to all EEE, cables and spare parts (to be phased in through July 2019) as well as the allowance to add new materials to the originally established listed six. In accordance with article 6(1) of the new directive (2011/65/EU), the risks to human health and the environment arising from the use of four particular plasticizing phthalates became subject to further investigation for possible future restriction. It also provided coherence with other EU legislation, such as European declaration of conformity and REACH (a general act regulating registration, evaluation, authorization and restriction of chemical substances). RoHS 2 required manufacturers, to produce documentation to ensure there are no restricted substances produced in EEE. On March 31, 2015, Directive 2015/863 was published, then made effective on July 22, 2019.

As of July 22, 2019, **RoHS Restricted Substances** include:

- Lead (Pb) < 0.10% = < 1,000 PPM
- Mercury (Hg) < 0.10% = < 1,000 PPM
- Hexavalent Chromium (Cr VI) < 0.10% = < 1,000 PPM
- Cadmium (Cd) < 0.01% = < 100 PPM
- Polybrominated Biphenyls (PBB) < 0.10% = < 1,000 PPM
- Polybrominated Diphenyl Ethers (PBDE) < 0.10% = < 1,000 PPM
- Bis(2ethylhexyl) phthalate (DEHP) < 0.10% = < 1,000 PPM
- Butyl benzyl phthalate (BBP) < 0.10% = < 1,000 PPM
- Dibutyl phthalate (DBP) < 0.10% = < 1,000 PPM
- Diisobutyl phthalate (DIBP) < 0.10% = < 1,000 PPM
